- Pax from Cat B countries will be subjected to random RAT. Those with negative result will be allowed to proceed.
- Pax with positive result will be quarantined for 10 days and RT PCR test will be done on 8th day. Negative cases will be allowed to proceed to home and positive cases will undergo additional quarantine or will be shifted to a hospital as per the advice of health authorities.

- Complete ban on inbound travel from Cat C countries.
- Only those holding an exemption certificate from an exemption committee would be allowed to travel to Pakistan.
- All pax 6 years and above, traveling via direct/indirect flights from Cat C countries would be subjected to RAT on arrival in Pakistan.
- Pax with negative RAT will be allowed to proceed while those with positive result will be quarantined for 10 days and RT-PCR test will be conducted on 8th day of quarantine. Those with positive result will undergo additional quarantined or shifted to a hospital as per the advice of health authorities.

 Pax with negative RAT but coming from Omicron variant countries, will be required go undergo 3 days mandatory quarantine and an RT-PCR test on 3rd day.

Category A

• All other countries, including Canada, are included in category A countries.

Covid Testing & Vaccination for traveling to Pakistan

- Only 100% fully vaccinated travelers, 15 years and above, will be allowed to undertake inbound travel to Pakistan.
- All pax 6 years and above (local/foreigners) coming from any country must posses negative PCR conducted within 48 hrs prior to commencement of travel.
- Deportees are exempted from test/report requirement.
- Pax transiting through KSA, Qatar and UAE will be randomly subjected to Rapid Antigen Test (RAT).

Exemption and Waiver

All Pakistanis can travel from Cat C countries without exemption till 15 December 2021.

Pakistanis unable to get vaccinated abroad (all categories) due to the following reasons are exempted from mandatory vaccination after producing certificate from a classified specialist doctor:

- Expired visa/emirates ID/ illegal immigrants/deportees
- Pending court cases
- Medical conditions/issues
- Pregnant women
- Partially vaccinated from Pakistan
